Congratulations on your purchase of Turf USA synthetic turf! We are confident in the quality and durability of our products, and we stand behind them with our 15-Year Limited Warranty. Please review the terms and conditions of the warranty:

1. Coverage: This warranty covers your Turf USA synthetic turf against the following:
 - Ultra-violet (UV) degradation: The turf over time may have slight color changes but will resist UV degradation, ensuring long-lasting color and structural integrity.
 - Quality assurance: The turf is manufactured using high-quality materials and meets our stringent quality standards.
 - Stain resistance: The turf is designed to resist staining from common substances such as pet urine, food spills, and organic matter.
 - Texture retention: The turf will maintain its original texture and feel, providing a consistent and pleasant surface.
 - Abrasive wear: The turf is built to withstand regular foot traffic and use without significant wear.
2. Exclusions: This warranty does not cover the following:
 - Damage caused by reflection from windows, vinyl or metal fences, metal beams, poles or blocks, metal or plastic furniture or playgrounds, concrete/stucco walls, or other reflective surfaces.
 - Damage resulting from the use of improper chemicals, cleaning agents or methods that may cause discoloration or degradation of the turf.
 - Damage caused by exposure to chemicals containing halogen group elements, high-intensity herbicides, pesticides, or chemical run-off.
 - Damage resulting from improper installation, misuse, neglect, or failure to follow the maintenance guidelines provided by Turf USA.
 - Labor for replacement or other non Turf USA supplied material component costs associated with the claim
3. Warranty Claim Process: If you believe your turf is experiencing issues covered by this warranty, please follow these steps:
 - Notify Turf USA of the issue within 30 days of discovery by contacting our customer service department.
 - Provide proof of purchase and any relevant documentation to support your claim.
 - Turf USA may request additional information, such as photographs or samples, to assess the claim.
 - Turf USA will evaluate the claim and, if deemed valid, provide a resolution as outlined in the warranty.
4. Resolution: In the event of a valid warranty claim, Turf USA will, at its discretion, either repair, provide replacement material for the affected turf or provide a prorated refund based on the remaining warranty period. Turf USA does not provide compensation for cost of labor associated with any warrantee claims.

Please note that this warranty is non-transferable and applies only to the original purchaser of the Turf USA synthetic turf.
